Genworth Australia (GMA) conducts a comprehensive review of gender pay equity outcomes as part of its review of remuneration review outcomes (salary increases and bonus awards). This gender pay equity review is completed on an annual basis.

The primary approach for the review was a like-for-like comparison. That is, to compare the remuneration of males and females by reviewing the compa-ratio (market competitiveness) for females and males to determine if there are meaningful differences in salary and bonus outcomes due to gender. The compa-ratio analysis was conducted by looking at average and median compa-ratios for males and females overall, by career band (ie seniority in the organisation) and by WGEA occupational category. The results of this detailed analysis showed that the median compa-ratio for female employees is 103% and for males is 102% indicating there is gender pay equity on a like-for-like basis within Genworth. This information was further dissected by analysis of the distribution of compa-ratios. This analysis looks beyond medians and averages and enables a comparison of the proportions of males and females that are paid below, at, and above market (referred to as compa groups) to determine if there are meaningful differences in remuneration competitiveness that are not identified by average and median analysis. This review was undertaken overall, by career band and by WGEA occupational category.

The testing of average and median base salary, total target remuneration and total actual remuneration by career band and WGEA occupational category was also undertaken. Where differences were identified, a review for statistical significance was conducted where sample sizes permitted, and the differences were investigated to determine the reasons for these differences.

Genworth achieved very positive results against its diversity objectives for the 2016/2017 reporting period. In particular of note were positive improvements in the areas of female representation at the Senior Management and Board levels, significant increase in the uptake of flexible working arrangements and continued focus on providing leadership on gender equality within and outside of the Company. A few highlights in relation to our diversity and inclusion initiatives are highlighted below:

Female representation in management

- In 2015, Genworth's Board committed to achieving a target of 30% female representation by the end of 2018. In 2016, Genworth's Board surpassed this target achieving 33% female representation, two years before the target date. In recognition of this achievement Genworth's Chair, Ian MacDonald, was invited to join the 30% Club, a group formed by the Australian Institute of Company Directors committed to achieving better gender balance in organisations. As a member of the 30% Club Ian MacDonald has made a public commitment to gender diversity as a business imperative and to lend his support to other Board Chairs in achieving the 30% target.

- Genworth also continues to have strong female representation on our Senior Leadership Team (CEO and CEO direct reports), with our current female representation on our Senior Leadership Team sitting at 38%. Two female appointments were made to the Senior Leadership Team throughout the 2016/2017 reporting period, including one internal appointment.

- Whilst gender diversity is evident at senior management levels, our mid-management levels have lower levels of gender diversity. To help address this, a Young Talent program focused on developing top talent females has been established. This program identifies and emphasises development of young female talent within the organisation. Employees participating in this program work towards achieving focused development plans to assist in their preparedness to take the next step in their careers. Since the program's establishment, 57% of program participants have earned promotions.

Flexibility

- Throughout the 2016/2017 reporting period, Genworth have continued to support flexible working and encourage uptake of flexible work arrangements throughout the organisation. Currently, more than half of our female employees and more than a quarter of our male employees have some form of formal flexible work arrangement.

- In recognition of our commitment to helping our employees achieve better work-life balance, Parents@Work recognised Genworth on International Women's Day as an employer that supports working parents. Along with 33 other companies, Genworth achieved this recognition by creating a family friendly workplace that supports the advancement of women, prevents discrimination, advocates for flexibility and creates equality for men and women in relation to access to Parental Leave.

Supporting gender equality in our community

- In our recent employee engagement survey (October 2016), diversity stood out as a major strength of our organisation with the question 'People of all backgrounds (cultural, gender, age, religion, etc.) can succeed in Genworth Australia' scoring an 86% favourable response rate. This is a great achievement with the Australian benchmark 9% lower for that question.

- Genworth's commitment to achieving gender equality also extends outside of Genworth and into the wider community. St Vincent De Paul is one of our key community partners and in late 2016, employees volunteered with Vinnies at the Marian Centre, a shelter for women and children experiencing domestic violence. Our volunteering efforts ensured the Marian Centre was able to re-open in late 2016.
